Competitors:

A team of 2 (two) participants from one school or 1 (one) participant from each school + 1 (one) model

Practical Task:

Create a Fantasy hairstyle and make-up according with theme "Sparkling glass"

- 1. Hairstyle 80 minutes
- 2. Make up -70 minutes
- 3. Complete image 20 minutes
- 4. Present the created image at the show. (3 min for each participant)
- 5. Photo session 10 minutes (per participant)

Description of the tasks and rules:

- 1. Contestants draw a sequence number.
- 2. The contestant creates a fantasy make-up according to the theme.
- 3. Model-without permanent makeup and without eyelash extensions.
- 4. Make up that includes artificial eyelashes and decorative elements (such as glues or other embellishments), ensuring that the total decorative elements on the face does not exceed 15%, creating a balanced and aesthetically pleasing look.
- 5.Before the competition the face and décolleté of the models can be used toning and correction(liquid, creamy products).
- 6. The contestant creates a fantasy hairstyle according to the theme.
- 7. It is allowed to use unusual materials, frames, decorative elements and others
- 8.The hairstyle can be done with postiche (products from excess hair) and decorative elements but not more than 50%
- 9. Models hair is clean, if necessary roll on curlers, formed with curling iron , hair crimper or straightening iron.
- 10. The image must be fully designed.
- 11. Contestants show created image with a performanced accompanied by music.
- 12. Models outfit is ready before the start of the competition.
- 13. The model is clothed according to the theme. 10 minutes are provided to complete the image after competition.
- 14. A cape shall be used for the model during the competition.
- 15. Model age not less than 16 years.
- 16. Work materials and water may be placed on the work surface during the competition.
- 17.The participants will arrange their workplaces and clean the competition premises as instructed by the workshop manager after completing the competition tasks.
- 18.Competitors must comply with the work safety rules in the workplaces. In case of noncompliance with the rules jury have rights to disqualify the participant.
